MINUTES FOR THE MAY 28, 2024 BOARD MEETING

New/Current Business:

- **A.** Tuesday, June 18 will be A Night at the Museum event from 6:00 8:00 p.m. Rob Logan confirmed that Wise Guys Pizza will be there, and Rosemary Taylor is lining up "characters" in costume for the night. Lois O'Donnell stated that the forum speakers are still being looked into. Both the house and barn will be open, and Lois will have a "make your own tornado" table for kids' set-up outside. She asked for anyone with empty 2-liter bottles to please donate. Evan Albaugh asked if the forum would be recorded and there was discussion surrounding options.
- **B.** Open Houses will be most Saturdays this summer from 10 a.m. noon, in conjunction with the Ankeny Uptown Farmers Market. Lois O'Donnell asked for volunteers to host.
- C. Summerfest Open House will be Saturday, July 13 from noon -3:00 p.m. Rosemary Taylor, Asa Hutton and Evan Albaugh volunteered to host. Jo Ann Adamson will inquire with the Ankeny Schools to see if the administrative offices can also be open for tours on that day/time.
- **D.** The Ice Cream Social will be held Sunday, August 25, 2024. Karla Kasper has volunteered to take over the planning duties this year.
